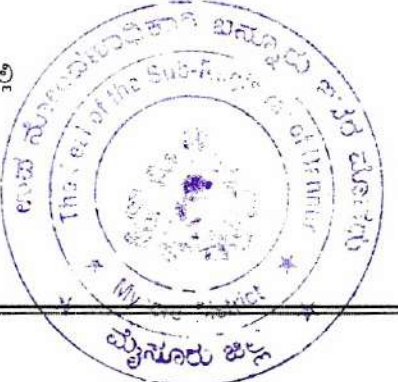

4. **CEASER OF MEMBERSHIP:** The trusteeship will be ceased for the following reasons.

7. He can make the inspections of the institution, projects and activities of the trust, as and when required in the interest of trust and its development.
 - b) The president shall transact all business in connection with the purchase and sale of all securities, shares debentures and stocks as may be necessary in the interest of the trust.
 - c) He/ She shall sign and execute all documents relating to the immovable Properties of the trust with the Secretary.
 - d) He/ She shall operate the bank account with the Treasurer.
9. THE DUTIES OF THE SECRETARY: The Secretary has to call the trust meeting as per the direction of the president/board of trustees, and to co-ordinate in the development of the trust.

 - b) FUNDS: The fund of the trust will be Rs. 10,000/- and it has been contributed by all the trustees equally. Apart ,from the existing Rind at trust, the trustees may raise funds from public or from bank in the form of loan.
12. APPROVAL OF CASH VOUCHERS: All the cash voucher should have the approval of the president and sign on each voucher to indicate his approval.
13. AMENDMENTS: In case of any Amendments to the rules and regulations of the trust or the memorandum of trust shall be carried out as per the provisions of the Income tax Act 1961.
14. CO-OPTION: In case of the vacancy or vacancies arises among the members of trust by whatever reasons it shall be filled in by remaining members of the trust with the consent of Board of Trustees.

- a) INCORPORATION OF INCOME TAX CLAUSES: The following clauses shall be incorporated in the rules and regulations of the trust with respect to Income-Tax requirements.
- b) ACCOUNT CLAUSE: There shall be maintained all accounts of the trust regularly. A chartered account shall duly audit the account. The accounts of the trust shall be closed by 31st day of March every year.

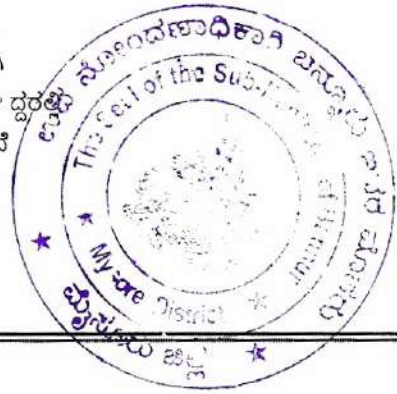
